 - a. Regional Depository Librarian's Report
 - i. Ed Hager left UK Libraries. A volunteer is helping with exchange lists and the turnaround time is now 6 months.
 - ii. More staff changes may occur soon due to the Library's reorganization.
 - iii. Government Documents processing at UK now resides in Collections and Technical Services.
 - iv. Sara Brown is the new depository librarian at ACTC.
 - v. Sandee McAninch has put forth a proposal for the creation of a GPO consultant position that would be hosted by UK.
 - vi. Six directors have returned the State Plan Letter of Agreement. Sandee will extend the deadline to December.
 - b. Kentucky State Publications Librarian Report
 - i. Bill Richardson was absent from the meeting but sent Leigh Troutman in his place. Leigh distributed a handout and asked that anyone with questions contact Bill.
 - c. KSLA Legislative Work on Depository Documents Regulation
 - i. Phil Yannarella stated that Bill Richardson is working on 725 KAR 1:040 but he does not know how far the work has progressed.
 - d. Nomination Committee/State Publications Committee
 - i. The previous Nominating Committee consisted of Rae Shepherd-Schlechter and Matt Onion. The next Nominating Committee will be appointed at the spring 2005 meeting.

- ii. Leigh Troutman volunteered to be on the State Publications Committee which now consists of Pat Yannarella, Phil Yannarella, Leigh Troutman, & Bill Richardson.
- e. Constitution & Bylaws Revision
 - i. Claudene Sproles and Angel Clemons revised Article IV of the Godort Constitution and sections IV.B.1-2, IV.C, IV.D, and V.C.2.a-b.
 - ii. **ACTION:** Angel Clemons will further revise Bylaws section IV.C and submit fully revised Bylaws to Patrick Davison for inclusion on the KLA Godort website.
- f. Review of Director's meeting at KLA fall conference 2004
